Wagner Adds Two Lawyers in Beantown

Marcia Wagner just hired a pair of lawyers in Boston. Watch for her to look further south to continue expanding her team.

Wagner confirms that **Candace Quinn** and **Michael Burwick** have joined the **Wagner Law Group**, boosting the Boston-based firm to 35 lawyers in total. And though she's open to bringing on "really, really knowledgeable" hires in many locations, she has one place in particular in mind for her next expansion.

As for Burwick and Quinn, the former joins as of counsel and the latter as a partner. Quinn, who most recently worked with **Mazars** in tax, energy and ERISA global executive compensation and employee benefits, specializes in international tax and benefits law, Wagner says.

Burwick most recently served as managing partner of Burwick Law and general counsel and chief compliance officer of **Trust Advisory Group** and **Advisory Group Equity Services**. He specializes in where ERISA, securities law, and Finra regulations meet.

"These are really senior folks, and they really know their stuff," Wagner says of Quinn and Burwick. "They're two really cool, really smart, really hardworking, frankly really nice people that are really joining us ... I'm really psyched!"

Quinn is an alumnus of Tulane, Suffolk, BU, and Vermont Law. Prior to joining Wagner, she spent more than four years at Mazars. Prior to that she worked at Squire Patton Boggs.

Burwick is alumnus of both BU and (several times over) of Georgetown Law. Prior to his time with his eponymous firm and with Trust Advisory Group, Burwick worked with Hunter Business Law, Day Pitney, 1031 Property Group, the

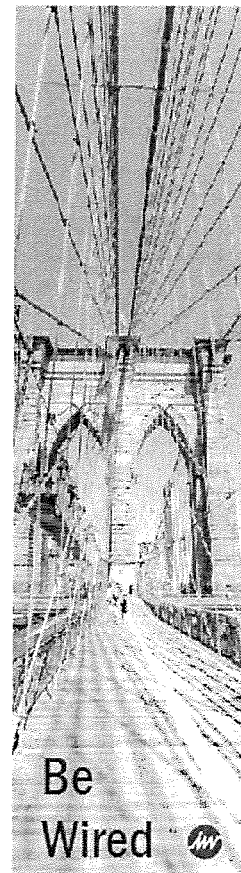
